

Good Friday

In observance of Good Friday, U.S. securities exchanges will be closed on **Friday, April 19, 2019**. However, Federal Reserve Banks and most of the nation's banking institutions will be open on that day.

Forex trading is expected to follow normal hours on April 19. For information on futures trading, we recommend you check with the individual exchanges: theice.com, cmegroup.com, and cfe.cboe.com.

Extended Hours Trading Overnight (EXTO) for equities will close at 8 p.m. ET on Thursday, April 18, and will resume at 8 p.m. ET on Sunday, April 21. No EXTO trades will take place on Friday, April 19.

Mutual Funds:

Certain mutual funds will close early on April 18, meaning no buys, sells, or exchanges after 2 p.m. ET. For information on a particular fund, please call Client Services at 800-669-3900.

TD Ameritrade Hours of Operation:

TD Ameritrade Client Services will follow our normal 24/7 hours of operation. However, branch offices and TD Ameritrade Clearing, Inc. will be closed on April 19.

Deposits and Withdrawals:

TD Ameritrade will continue to receive and process the following transactions on Friday, April 19:

- Incoming wire transfers, including company or firm money movements
- Incoming check deposits
- Bill pay
- Incoming direct deposit
- Outgoing firm wires
- TD Bank check writing and debit card transactions

However, since system posting will be down, clients will not see transactions applied to their accounts until Monday, April 22.

TD Ameritrade **will not be processing** the following transactions on Friday, April 19:

- Outgoing client wire transfers
- Incoming and outgoing electronic funding (ACH)
- Outgoing check disbursements
- Stop payment requests
- Returned checks

Settlement:

Good Friday is not a settlement date for stocks or mutual funds. Mutual fund trades made on April 18 will settle one business day later than usual. Stock trades made on April 17 and 18 will settle one business day later than usual.

Options Expiration:

Due to the holiday, weekly options expiration will take place on **Thursday, April 18**, since the exchanges will be closed on Friday, April 19. Intentions should be submitted before 5:30 p.m. ET on Thursday.

Bond Markets:

- Bond markets will close at 2 p.m. ET on Thursday, April 18. The TD Ameritrade Fixed Income Sales group (800-934-4445) will be available between 8 a.m. and 2:30 p.m. ET on April 18.
- Bond markets and the TD Ameritrade Fixed Income Sales group will both be closed on April 19.
